# **Regional Work Plan Overview**

# **1. Homelands Housing and Infrastructure Program**

The 2022-23 Federal Budget released on 25 October 2022 provided \$100 million over two years, (\$25 million in 2022-23 and \$75 million in 2023-24) to address urgent housing and infrastructure needs across NT homelands. The funding is being delivered through a new Federation Funding Agreement with the NT Government.

The NT Government has established the Homelands Housing and Infrastructure Program (HHIP) to facilitate the investment.

The HHIP is managed through the Department of Territory Families, Housing and Communities (TFHC), however decisions regarding planning, project selection and implementation are overseen by the Joint Steering Committee (JSC), which includes the following members:

- Central Land Council (CLC)
- Tiwi Land Council (TLC)
- Anindilyakwa Land Council (ALC)
- Northern Land Council (NLC)
- Aboriginal Housing NT (AHNT)
- Australian Government (AG)
- Northern Territory Government (NT Government)

# 2. Regional Work Plan – Overview

The JSC has agreed that Regional Work Plans will be developed by the NT Government in partnership with land councils and AHNT.

Regional Work Plans will set out key regional priorities regarding housing and infrastructure needs.

Plans will guide the allocation of \$54 million (2023-24) and provide the basis for potential future project prioritisation, should additional funding be identified.

The JSC has endorsed the following investment principles that guided project selection in 2022-23:

• Homelands with a population over 50 persons (including the clustering of smaller connected homelands);

- Housing and infrastructure that is in average/poor condition and requires investment beyond regular repairs and maintenance;
- Homelands with existing access to education, and other services;
- Homelands within proximity of a regional community

   in recognition that homelands can reduce pressure
   on housing and other resources; and
- Works that respond to key Homelands Housing and Infrastructure audit findings.

# 3. Regional Work Plan – 2022-23

In 2022-23, the following works were delivered through a \$25 Million Rapid Response and distributed as follows:

- \$1.25 million administration costs (5%);
- \$5.2 million Housing and Infrastructure Upgrade Program in Utopia;
- \$4.3 million NT wide initiatives to improve water, power and sanitation for all funded homelands; and
- \$14.25 million targeted investment into selected homelands which was distributed through four Northern Territory Land Council Regions.

- Bartalumba Bay housing upgrades \$0.55m
- Thompson Bay housing upgrades \$0.25m



### 4. Regional Work Plan 2023-24 - Development Process

Timeline for the development of regional work plans is set out below:



Whilst the process for each Regional Work Plan has been tailored to suit local governance structures, JSC members have generally performed the following roles:

#### Land councils

- Develop principles to guide investment decisions; and
- Engage with Traditional Owners, Councillors and homeland service providers to determine priority projects.

#### AHNT

• Engage with homeland service providers to determine key housing and infrastructure issues and priorities.

#### **NT Government**

- Provide background information regarding housing and infrastructure on homelands, including any capital upgrades completed or underway; and
- Assist in the coordination of the Regional Work Plans.

# 5. Regional Work Plan 2023-24 - Funding Allocations

The allocation of the \$54 million (2023-24) between land council regions has been guided by the proportion of funded dwellings in each land council region:

Anindilyakwa Land Council (ALC) and Tiwi Land Council (TLC) do not require a Regional Work Plan. As smaller, standalone land councils with unique housing arrangements, ALC and TLC will be provided with funding in 2023-24 to put towards identified priorities. This approach will reduce the administrative burden and allow NT Government and AHNT to focus on more complex decision-making processes required to drive works in the Central Land Council and Northern Land Council regions.

# 6. Stakeholders

#### 6.1 Northern Land Council (NLC)

The Northern Land Council (NLC) represent constituents across their region. The NLC have established their own additional principles and governance arrangements to determine how HHIP projects will be prioritised across each region.

The NLC was established in 1973. Following the enactment of the *Aboriginal Land Rights (Northern Territory) Act 1976* (Cth), the NLC became an independent statutory authority responsible for assisting Aboriginal people in the northern region of the NT to acquire and manage their traditional lands and seas.

The Land Rights Act combines concepts of traditional Aboriginal law and Australian property law and sets out the functions and responsibilities of the Land Councils. A key function of the NLC under the Act is to express the wishes and protect the interests of Aboriginal people throughout its region.

The NLC is also a Native Title Representative Body under the *Native Title Act 1993* (Cth) (Native Title Act).

The NLC represents more than 51,000 Aboriginal people. Within its jurisdiction, it assists Traditional Owners by providing services in its key output areas of land, sea and water management; land acquisition; minerals and petroleum; community development; Aboriginal land trust administration; native title services; advocacy; information and policy advice. The NLC's vision is for a Territory in which the rights and responsibilities of every Traditional Owner are recognised and in which Aboriginal people benefit economically, socially and culturally from the secure possession of their lands, seas, waters and intellectual property. Our mission is to ensure Aboriginal people in the NLC's region acquire and manage their traditional lands, seas and waters, through strong leadership, advocacy and management.

As at July 2023, there are 204 homelands eligible for funding under the NT Government's Homelands Services Program in the NLC region. Most dwellings on homelands are decades old, as is the supporting infrastructure.

#### 6.2 Aboriginal Housing NT (AHNT)

AHNT is the peak body for the NT Aboriginal Community Controlled Housing Sector - including homeland and town camp service providers. AHNT advocates strongly for the returned control of housing development and management to Aboriginal people, their organisations and communities, and for the decentralisation of housing and homeland service delivery back to Aboriginal communitycontrol.

AHNT works closely with the Northern Territory and Australian governments, land councils, and other key partners to help build capacity and provide advocacy for the sector who currently provide housing and housingrelated services to around 10,000 Aboriginal Territorians, living in around 2,426 dwellings, across 394 homelands, and 43 town camps and community living areas across the NT.


# 7. Investment Principles

The NLC's constituency is a representation of the Traditional Owners within its jurisdiction. There are seven regions within the NLC's jurisdiction: Darwin/Daly/ Wagait; West Arnhem; East Arnhem; Katherine; Victoria River District (VRD); South East Arnhem; and Borroloola/ Barkly.

The NLC has a small team of 3.5 staff who focus on housing policy, including outstations/homelands. The NLC housing team represent the organisation on the National Partnership for Remote Housing Joint Steering Committee.

Additional NLC principles are:

- Works are not to be covered by any other funding agreement or project; and
- Funds are to be distributed across the seven NLC 0 regions directly to Service Providers who have the capability and capacity to undertake the works. The regional distribution will be based on the number of serviced homelands in each region.

# 8. The Homelands Housing and **Infrastructure Audit Findings**

In May 2022, the NT Government commissioned an audit of 100 NT funded Homelands across the Northern Territory.

The existing condition of houses, water supplies, electricity supplies, sanitation services and municipal assets was assessed in 20 Homelands in each of the five NT regions (Central Australia, Barkly, Big Rivers, Top End and East Arnhem).

The key recommendations from the audit were considered to assist final development of the Regional Work Plans.

### 9. Northern Land Council Work Plan - Priority Projects for 2023/24

Based on detailed information received from Service Providers, consultation with AHNT and NT Government, the NLC recommended priority projects in line with agreed principles. One page summaries for each project are at Appendix B.

The scope of works described in the Work Description are indicative only. Final works will be agreed in consultation with residents.
